SIIX Corporation hereby announces that we resolved at the meeting of the Board of Directors held on April 21, 2006 to enter into a business alliance and capital participation arrangement with TOYO iTEC Co., Ltd. (Head Office: Kadoma City, Osaka Prefecture; President: Hitoshi Takaba) in connection with EMS (electronics manufacturing service) operations as follows:

1. Reasons for the Business Alliance

Our core business, EMS operations have developed mainly overseas in recent years with certain exceptions, in response to the movement toward the expansion of overseas production by manufacturers. However, for many reasons such as delivery time, production volume, and product lines, there still continue to be some projects where production in Japan is required to meet the demands of our main customers, Japanese electronic manufacturers, etc. TOYO iTEC is a company with more than 50 years experience in the areas of assembly and manufacture of electronic equipment such as printed circuit board assembly, and also has some unique technology in areas such as mountings, design, and the maintenance of mounting machines.

Through the business alliance with this company, we are intending to respond to the wide-ranging outsourcing needs of customers both in Japan and overseas to expand our customer base, and to construct a mutually supportive relationship in the areas of component procurement, manufacturing technology and design development at the same time.

In addition, to make this an efficient and solid alliance relationship, we shall acquire 10% of TOYO iTEC's outstanding shares and enter into a capital participation arrangement.
