Announcement of establishment of a subsidiary in Indonesia

SIIX corporation ("SIIX") hereby announced that it has decided at its board of directors' meeting held on today to establish a subsidiary in Indonesia. The subsidiary is supposed to assemble and manufacture circuit boards, electronic components, devices and etc.

1. Purpose of establishment of subsidiary

Indonesia, its population and economic magnitude are the biggest in ASEAN, keeps steady economic growth in accordance with stable political situation recently. Especially domestic demand of consumer products such as automobile, motorcycle and home electrical appliance is expanding gradually, and Indonesia is considered to be new eligible place for foreign direct investment in South-eastern Asia. Under such circumstances, SIIX decided to establish a factory near Jakarta, where many electronic-related and automotive-related companies of our main customers, are gathering. Also SIIX determined to expand its business in Asian countries by offering our advantaged high quality mounting technology, manufacturing and assembly services of electronic products to promising local production of foreign companies.

Moreover, SIIX, on the one hand, already owned a manufacturing subsidiary in Batam (PT SIIX Electronics Indonesia), which is handling mainly EMS (Electronic Manufacturing Service) business with customers outside Indonesia. On the other hand, this newly established subsidiary, SIIX's first manufacturing subsidiary in Java, Indonesia, is targeting to build up its business with customers in Indonesia.
